

AN APPEAL

Dear Parents,

However, we would like to make an earnest entreaty to those parents, who are willing to pay the entire amount, to do so, to enable us to meet our fixed establishment charges. We remain committed, as always, to ensure the all-round development of our children. We look forward to your continued cooperation in keeping the school functional.

Abiding by the directions given by the Honourable High Court, Calcutta on 13.10.2020, the revised Fee Structure for the current Financial Year 2020 – 2021 is given below.

Please note that the following fees have been waived from all classes:-

1. Sports Fees - 100 %
2. Library Fees - 100 %
3. School Magazine Fees - 100 %
4. ECA Fees - 100 %
5. Practical Fees - 100 %

This is for your kind information that with the above reduced fee structure, cumulative effect for the school will be a loss of a huge amount. Hence, it will be very difficult for the school to meet the essential expenditure including staff salary, necessary maintenance etc and the sustainability of the school will be at stake.

In terms of the directions of the Honourable High Court, guardians are requested not to avail the reduction in fees as laid down above if their financial situation does not merit such reduction. This will enable the school to continue to run smoothly and provide quality education without any interruption. These parents are requested to intimate us via email at waive@hariyanavidyamandir.org

Guardians who have already paid fee at the existing rate and wish to obtain the reduction in fees will not be entitled to any refund for the fees already paid. However, the excess amount paid by them, after giving effect to the order of Honourable High Court, will be adjusted against the payment of fees for the 4th quarter. These parents are requested to pay the 4th quarter fee by Demand Draft only at the School Counter

The fees as prescribed above, at the existing or reduced amount as applicable, for the 1st, 2nd and 3rd quarter 2020 is required to be tendered by all guardians by 30th November 2020, as directed by the Honourable High Court (through our online fees payment portal). In case the fees are not paid within 30th November 2020, the school, in terms of the order of the Honourable High court shall be entitled at its discretion to debar any student from attending classes (both online and physical, as the case may be) from 8th December 2020 onwards and withdraw all other facilities which are currently being availed by them.
