The undersigned is directed to state that the State Govt.
in the Education Department has No objection to Hariyana Vidya
Mandir, BA-193, Sector I, Salt Lake City, Calcutta-64 in the matter
of its receiving affiliation with the Central Board of Secondary
Education, New Delhi subject to the following terms and conditions:

- 1) The State Govt. will bear No financial liabilities in this
respect; at present or in future.
- 2) Seven percent of the total admission to the school made every year
shall be kept apart for the candidates recommended by the
School Education Department, Govt. of West Bengal; and that
fifty percent of such recommended and admitted candidates should
be allowed to study in the school, free of all charges.
- 3) The School will not enhance the tuition fees without the prior
approval of the State Govt., in writing; and
- 4) The School will grant scales of pay to the teachers and non-
teaching staff of the School comparable with the pay scales
approved for the teachers and non-teaching employees of
aided non-Govt. Schools in West Bengal.
